# New & Special Business | MICHAEL BRACKETT

#### 1. Player Incident: Disciplinary committee

• Disciplinary committee met via phone conference on Thursday April 18<sup>th</sup>. Committee needed more information from both parties involved. Reached out to both families and coaches and had a discussion concerning the incident that occurred at Mondays practice (4/15/24). After reviewing both sides of the story, the committee recommended that both

parties should review the Code of Conduct (Article 7 Rule 3) and follow up with a PSC board member going to a practice to discuss the Code of Conduct with the team.

#### 2. Coach Incident
